# QUESTION 4

## Law Proposed by Initiative Petition

Do you approve of a law summarized below, on which no vote was taken by the Senate or the House of Representatives before May 6, 1992?

### SUMMARY

This proposed law would impose an excise tax on oil, toxic chemicals, and other hazardous substances, and would direct that the money raised, along with the fees paid by hazardous waste transporters and specific revenues under other state laws, be deposited in the state Environmental Challenge Fund. Money in the Fund would be used, subject to legislative appropriation, to assess and clean up sites that have been or may be contaminated by oil or hazardous materials, and to carry out and enforce the excise.

As of July 1, 1993, the excise would apply to persons, businesses, and other entities possessing 50,000 pounds or more of oil and toxic chemicals covered by the proposed law. Toxic chemicals would be covered if classified as toxic by the federal Environmental Protection Administration (EPA) under federal law. As of July 1, 1994, substances listed as hazardous by the EPA under federal law would also become subject to the excise.

Until June 30, 1995, the excise would be two-tenths of one cent (\$0.002) per pound. In later years, the state Commissioner of Revenue would set the excise rate at a level, not to exceed two-tenths of one cent per pound, sufficient to yield \$35 million annually in 1995 dollars.

The excise would not apply to gasoline or other special engine fuels, jet fuel taxed under other state law, numbers 1 or 2 fuel oil, kerosene, animal or vegetable oil, or waste oil classified as hazardous waste under other state law. Nor would the excise apply to oils, toxic chemicals, or hazardous substances merely being shipped through Massachusetts; or contained in a consumer product intended for retail sale;

or present in a mixture at a concentration of less than one percent; or present in hazardous waste being transported by a licensed hazardous waste transporter who had paid or will pay a transporter fee under state law; or for which the excise tax has already been paid under the proposed law and which have not been reprocessed or recycled since payment of the excise.

The excise also would not apply to oils, toxic chemicals, or hazardous substances that are possessed by individuals for personal, non-business purposes; or are contained in vehicles or vessels intended to be used for normal purposes; or are produced in Massachusetts as a by-product of pollution control equipment or the clean-up of hazardous materials and are handled in compliance with federal and state environmental laws. Finally, the excise would not apply to toxic chemicals or hazardous substances in a manufactured product the use of which requires a specific shape or design and which does not release toxic substances under normal use.

Under the proposed law, the excise would ordinarily be collected from the first person or business within Massachusetts to come into possession of materials subject to the tax. If that person or business had not paid the excise a later possessor could be required to pay the excise and could then recover a corresponding amount from the first possessor. The proposed law would provide credits for excises paid on materials that become ingredients in the manufacture of other materials subject to the tax, and it would provide credits for similar excises or taxes paid to other states.

Persons possessing more than 25,000 pounds of materials subject to the excise in any six-month period would be required to obtain a license from the Commissioner of Revenue. The Commissioner could issue regulations establishing record-keeping and reporting requirements for persons possessing such materials. The Commissioner would collect the excise through procedures similar to those for other state taxes and could issue regulations to implement the proposed law.

The proposed law states that if any of its provisions were declared invalid, the other provisions would remain in effect.

#### SUMMARY OF PROPOSED DUKES COUNTY CHARTER

The proposed charter follows the county manager plan, under which the county would be governed by an elected board of commissioners, a county manager appointed

- Organize the work of county departments subject to the administrative code adopted by the board; supervise, direct and control these departments; review their administration and operation and make appropriate recommendations to the board; and order any agency under the manager's jurisdiction to perform any task for any other agency on a temporary basis if the manager, in his or her discretion, deems it necessary;
- Enforce the county charter and applicable laws, and assure that all terms and conditions imposed in favor of the county or its people in any statute, franchise or other contract are performed;
- Sign contracts, bonds, and other instruments for the county, negotiate contracts for the county, subject to board approval and, where appropriate, advisory board approval; and supervise the care of all county property;
- Appoint the deputy manager, if that position were created by the board, to serve at the manager's pleasure and assist in county administration;
- Appoint the heads of all county departments, heads of divisions within departments, and all other administrative officers and county personnel not otherwise provided for in the charter;
- At the manager's discretion, remove or suspend appointed county officials and employees, subject to the general laws and applicable civil service regulations;
- Serve as a nonvoting member of all appointive bodies in county government;
- Analyze and forecast trends in county services, finances, and programs, and report and recommend thereon to the board, including recommendations concerning county improvements; and
- Report annually to the commissioners, the advisory board on county expenditures, and the people on the state of the county, the work of the previous year, and any recommendations for the improvement of the welfare of the county and its residents.

#### The Board of Commissioners

The board of commissioners would exercise the legislative power of the county. Each January the board would select a chairman and a vice-chairman from among its members. The county manager could participate in all board meetings but could not vote.

The board would exercise its power by ordinance, except that the board could by resolution do the following:

- Approve contracts presented by the county manager; establish county personnel policies; elect, appoint, and remove officers and employees where permitted by law; express disapproval of the suspension or dismissal of other officers or employees; adopt rules for the board and its meetings; establish board committees; express board policies or opinions; conduct investigations; declare emergencies; and establish a municipal advisory council.
- The board would have the power and the duty to:
  - Appoint the county manager and could create the office of deputy manager.

- Appoint a clerk to the board, to serve at the pleasure of the board or for such term (up to three years) as the board may provide;
- Appoint a county counsel to head the county's legal department; the counsel would serve at the pleasure of the board or for such term (up to three years) as the county administrative code may provide, and the code could also establish a term (up to three years) for the position of assistant county counsel;
- Appoint members of all boards and commissions and other bodies whose manner of appointment is not otherwise specified in the charter;
- Approve annual operating and capital budgets, prior to presenting them for advisory board appropriation; and
- Pass those ordinances and resolutions deemed necessary and proper for the good governance of the county.

**Relationship of the County Manager to the Board of Commissioners**

The board would deal with matters involving county employees, administration, or services only through the county manager, except as otherwise provided in the charter. The charter would not prohibit a board inquiry into any act or problem of the county administration if relevant to the board's legislative powers.

Any commissioner could require a report on an aspect of county government at any time by making a written request to the county manager. The board could, by majority vote, delegate members to consult with the county manager to study any matter, and by like vote could require the county manager to appear before the board with such county records, reports, officials, and employees as the board deems necessary.

No member(s) of the board could seek to influence the county manager to appoint, promote, or dismiss any person to or from any county position, except that the board could prevent the suspension or dismissal of officials and employees by a two-thirds vote of its membership after a public hearing.

**The County Government**

The county government would have the power, subject to the provisions of general law and the state constitution, to:

- Organize its internal affairs and structure, including, with the exception of judicial or penal matters and the registry of deeds, the power to abolish or consolidate agencies previously required by general law, but any such action that changed the county's obligation to provide services previously supplied would require prior approval by the Legislature.
- Create and abolish agencies, offices, and positions, and establish the powers, duties, qualifications, compensations, and manner of appointment and removal of officials and employees;
- Adopt, amend, enforce, and repeal ordinances and resolutions; construct, acquire, operate, and maintain public improvements, projects or other enterprises for public purposes; sue and be sued; enter contracts; buy, sell, lease, hold and dispose of property; appropriate and spend money for county purposes; and exercise powers or eminent domain, borrowing and taxation only as provided by general law.

**The County Manager**

The county manager would:

- Serve as the full-time chief executive of the county;
  - Be appointed by a majority vote of the board of commissioners for an indefinite term and be paid a reasonable salary, fixed by the board and not subject to reduction while the manager remains in office;
  - Be required to reside in the county after appointment, unless permitted otherwise by the board; and
  - Be subject to removal by a majority vote of the board after written notice of charges or complaints followed by a public hearing, and could be replaced in case of physical or mental incapacity.
- The county manager would have the power and duty to:
- Propose to the board an annual operating budget and a capital budget, and supervise and administer all phases of the budgetary process, including such centralized personnel and purchasing procedures as may be authorized and including an examination of the records and operations of any county agency;
  - Oversee the county treasurer's collection of revenues, control of expenditures and complete accounting for all expenditures;
